



██████████ was incarcerated at Monterey County Jail where she was sexually abused and coerced to perform sexual acts by Monterey County Sherriff Deputy Marlon Alvarenga. The administration and officials operated the jail in such a way to allow these attacks on ██████████. The jail failed to have proper safeguards in place to prevent male prison guards from being in one on one situations with female inmates. Upon information and belief, other female inmates had complained about Alvarenga or jail officials and other jail employees had a reason to suspect or believe he should not be left alone with, or posed a substantial risk of serious harm to, female inmates. ██████████ suffered damages as a result of the coerced sexual acts and her federal civil rights and state rights have been violated. Specifically, the right to be free from cruel and unusual punishment, including sexual abuse, under the 8th Amendment via 42 U.S.C. 1983. A Monell claim may exist for the prison's pattern and deliberate omission of policies in place to prevent such acts of misconduct. ██████████ also has state law claims for intentional infliction of emotional distress, battery, negligence and violations of the Bane Act. ██████████ also has claims for deliberate indifference of jail officials and employees as well as negligent training, supervision and staffing. These claims are not exhaustive of all the potential claims that may exist and that may later be developed through discovery in any civil action filed. Instead, this notice of claim and the listing of these potential claims, puts the County on notice of the general species of the claims asserted and the conduct from which they arise. ██████████ has been both physically and psychologically damaged in an amount greater than \$1,000,000.00 which includes, past physical and mental pain and suffering, future physical and mental pain and suffering, future medical expenses for psychological treatment and counseling.

The undersigned states: That the above claim and the items as therein set out are true and correct; that no part thereof has been heretofore paid, and that the amount therein is justly due this claimant, and that the claim is presented within 180 days from the date that the cause of action occurred.
